

Minutes of the AIS Zoom Board meeting, September 25, 2024

NOTE: The attendance is located at the end of these Minutes.

The meeting was called to order at 5:02 pm PDT.

A quorum was present.

1. Minutes of August 28 Zoom Board Meeting – Claire Schneider

Motion 1: To approve the Minutes of the August 28 meeting with corrections from two people.

Motion by Janis Shackelford and seconded by Bonnie Nichols. Motion approved.

REPORTS

2. Calendar – Susan Driver

A digital report was posted, information only.

John Ludi asked that the number of printed copies of the AIS 2026 Calendar be reduced to 600 copies. He still has many copies of the 2025 Calendar in the Storefront and suggested that AIS doesn't need that many leftovers of the 2026 Calendar. John has posted a notice in the next *News & Notes* about the surplus of 2025 Calendars.

3. Photo Contest – Susan Driver

A digital report was posted, information only. Sixty-five adult and 6 youth participants submitted a total of 342 photos. The contest results and photos have also been sent to the AIS webmaster, AIS editor, and AIS Bulletin Editorial Board. Susan thanked the hybridizers who contributed rhizomes for the winners: Rick Tasco, Mike Sutton, Hugh Stout, Terry Aitken, Hooker Nichols, Linda Miller, Thomas Johnson, Howie Dash and Delane Langton. She also thanked the judges: Heather Haley, Earnie Royal and Bonnie Nichols.

4. Digital Programs – Jean Richter

A digital report was posted, information only. In addition to a pdf, the actual list of digital programs has been posted on the AIS website. Jean requested donations of more digital programs, especially of beardless irises and programs that are germane to specific geographical areas such as the Southwest or the Midwest. Most programs are in a PowerPoint format and are available either as a downloadable program attached to an email or as a link to a Google Drive, if too large to be attached to an email.

5. PR and Marketing – Bob Pries & Doug Chyz

A digital report was posted, information only. Bob has been interviewed by a *Garden* writer for an article about native irises. A link on the *Iris Encyclopedia (the wiki)* to a

spreadsheet of iris exhibitions has been set up and continues to be updated by Doug. Today, Bob received a request for information about how affiliates could create and manage a website. Wayne Messer has created web pages in the *Iris Encyclopedia* and on the AIS website for affiliates. At the next AIS Board meeting there will be an update about a template for creating a website within the AIS organization. Jody Nolin will survey attendees at the next Affiliate Work Group meeting about their need for a website template.

6. *Iris Encyclopedia* (the wiki) – Bob Pries

A digital report was posted, information only. Bob began his report by saying there were 453,007 unique visitors to the *Iris Encyclopedia* (the wiki) in September. But this is a lie!! Bob said. About 80% of those “visitors” are from China and after conferring with Tim Valenzuela, the conclusion is that these “visitors” are Chinese bots. The question is, what are the bots doing? And is there a way to know how many real visits there are to the *Iris Encyclopedia*?

The join button (membership) has been added to the wiki. Bob proposed that a donation button be added periodically to the wiki, a button similar to what sometimes is seen on the Wikipedia website. Coding should be added to allow the donor to direct their donation to a specific AIS program. Next was a discussion about phishing and the security of emails.

7. Image Coordinator – Janis Shackelford

A digital report was posted. Currently, the Online Iris Register only accepts photos that are larger than 1 MB. If the photo is smaller, it is returned to the hybridizer with a request for a photo with a larger resolution. Janis has received a couple of requests to reduce the size required of photos that are submitted with a registration. She asked the AIS Board to approve a reduction in resolution for photos submitted with an iris registration. This would require a change to the registration form in the Online Integrated System. Janis said that a reduction to 600 KB would be acceptable.

8. AIS Fall Board Meeting – Bonnie Nichols

Because of low registration for the AIS Fall Meeting, the meeting venue and hotel have been changed. The Board will be meeting at the Farmer’s Branch Recreation Center. Bonnie has reserved a 15-passenger van to transport attendees to the Rec Center. The plan is that attendees will stay at a common hotel near the airport making it more efficient to transport everyone to the meeting. The Fall Meeting will be a one-day event with an estimated cost of \$1200. Because this AIS Board Meeting will be a hybrid

Zoom meeting, an effort will be made to prepare the room for open communication among all participants. Tentatively, the meeting will begin at 9 am Dallas time.
